#### **OVERVIEW OF FINANCIAL STRUCTURE**

The IMPBA organization is a 501(c)(4) non-profit corporation. Sources of income include: Memberships, Club Sanction Fees, Race & Record Trial Sanction Fees, and Newsletter Sponsor Fees. Other fees include printed Rule Book and printed Newsletter, however, costs for these items may exceed fees charged. Donations to the organization are accepted, but are not tax deductible as IMPBA is not a charitable organization. The Secretary & Treasurer ensure compliance with all Federal, State and Local laws regarding non-profit corporations as they relate to Indiana (original state of incorporation) and Ohio (physical office location). Year-end 990 Federal Informational Return is prepared by Vowells & Schaaf, LLP, CPAs. Compliance with By-Laws & Constitution of the IMPBA are ensured in that no two persons domiciled together may sign for any funds. Three officers hold signature rights on the bank accounts. The organization holds: a Savings Account which serves as an escrow for insurance purposes and maintains a minimum; a Regular Checking Account for normal business operations; and a PayPal Sub-Account for the sole purpose of being used for transfer of funds. This was instituted as a stop-gap measure in the event of data compromise of the payment system. Fund transfers are routinely done. The bank accounts are currently no fee (with exception for non-sufficient fund, returned items, or foreign conversion.) Transaction processing fees based on a percentage of transaction and a flat amount per transaction.

Petty cash will be paid by MasterCard and a detailed report is received by Treasurer monthly. No cash fund is kept at the office. All expenses require a valid receipt be on file.

#### A Hydro & B Hydro as separate US-1 Classes

#### Purpose:

To separate the .12 Hydro (A) from the .21 Hydro (B) in US-1 competition.

#### Reasoning:

In previous years there were a significant number of Nitro entries, and A/B and C/D were combined to save time. Today with the speed and size of the .21 riggers, a .12 doesn't have a chance of finishing a heat when they are run together. Nitro classes should have equal rights to compete and reap the same rewards.

The following PROCEDURE SECTION Proposal will go before the membership for vote in December.

The Board of Directors is recommending passage of this proposal.

If passed, this rule change will become an official part of the Rule Book beginning with the 2023 season.

#### **ELIMINATE 300-MILE RADIUS RULE**

#### **PURPOSE:**

The proposed change to eliminate the 300-mile radius rule that restricts scheduling of other events the weekend prior to, and weekend(s) of a US-1 format event will benefit the IMPBA and its membership by allowing District Directors to determine if they need to schedule around a US-1 Internats event, as they do for all other National stye events (as there is no such restriction for those events).

Multiple power sources are offered and run at other events, and the impact on a National or Internats is minimal, however, taking (up to) 3 weekends out of a District schedule can have a huge impact on that Districts ability to offer events to the membership who were not planning to attend a large National or Internats event.

Our organization's mission is to promote the hobby and allow our members multiple opportunities to enjoy the hobby. Participants may choose to attend an event or not – limiting scheduling of other races does not "force" or "encourage" members to attend one or the other.

#### D. Restrictions

- 1. All sanction requests and fees must be submitted to the IMPBA office to be included on the Master Schedule.
- Sanctions will only be granted to clubs officially registered with IMPBA, who have paid the Club Registration fee and obtained an IMPBA insurance certificate covering the water for the calendar year the race is to be sanctioned in.
- All Sanction requests require the approval of the District Director who has the responsibility of coordinating all activities in his or her district. Record Trials also require approval of the Records Director.
- 4. Contest Directors listed on sanction form must have successfully completed the CD test.
- 5. Sanctions will not be granted for events within such dates or distance of each other where the sanctioning officials have reason to believe that success of either event might be jeopardized.
- 6. No IMPBA sanctions will be granted the weekend prior to, or the weekend of an International Regatta, within a 300-mile radius of the host site. Sanctions that do not offer any US - 1 classes will be exempt from the radius restriction.

#### **SECTION E-IMPBA PROCEDURES**

...

#### **III - ANNUAL INTERNATIONAL and NATIONAL REGATTAS**

#### A. Definitions

"International Regatta (Internats)" and "National Regatta (Nationals or Nats)" shall be defined as a premier sanctioned event which may be held annually for each power division (Nitro, LSG, FE) where an approved "Internats US-1" or "Nationals" championship format is followed. Depending upon format chosen and number of entries, these events will take from 3 to 8 days not including open water.

#### **B.** Requrements

An IMPBA International Regatta (Internats) or National Regatta (Nationals) will be awarded on a rotational basis between the various districts and held annually during June, July or August. Any deviation from the June - August time frame must be approved by the IMPBA Board of Directors.

- 1. An IMPBA International Regatta will consist of three events: 1/16 mile straightaway (SAW) trophy trials; 1/3 mile oval trophy trials; and multi-boat racing using one of the approved US-1 formats.
  - a. US-1 eligible classes are listed in each respective power section: Nitro, LSG, Fast Electric.
  - b. A minimum of 8 contestants per class must present a boat to run in all three events for that class to be considered US-1 eligible.
  - c. Optional special events may be run after completion of all US-1 events.
  - d. At the International Regatta, the winner of any class scheduled by the host club and approved by the Board will be awarded "US-1 International Champion". Classes that do not make US-1 status may be run and awarded "National Champion". Special events winners will be awarded First, Second, Third Place.
- 2. An IMPBA National Regatta will consist of multi-boat heat racing run using one of the approved Nationals formats.
  - a. Established IMPBA engine classifications will be offered for National Champion status.
  - b. Optional special events may be offered.
  - c. A minimum of 6 boats per class must be presented for racing.
  - d. The winners at an IMPBA National Regatta will be awarded "National Champion". Special events winners will be awarded First, Second, Third Place.

#### C. Restrictions

No IMPBA sanctions will be granted the weekend prior to, or the weekend of an International Regatta, within a 300-mile radius of the host site of the International Regatta. Sanctions that do not offer any US - 1 classes—will be exempt from the radius restriction.

#### C. Applying and Acceptance

Clubs will bid to hold Nationals or International Regatta events. Bids should be submitted to the National Nitro, LSG, or Fast Electric Director. The President will review and make recommendations to the District Directors. Bid approval requires a majority vote of the Executive Board.



He has been known to gift boats to people just as a way to get them interested in the hobby. He is known for his habit of showing up at a race on Friday, pulling out his lawn chair, and watching others practice, as he had done so much testing at his pond in Winnie, TX, that he didn't need open water at the race site. Ernie is a strong believer in doing it right, and is meticulous about his note-taking and staying organized.

Ernie joined the IMPBA and District 7 in 1989, and is known for his passion for the hobby, consistency, and willingness to help others excel. He understands that without people involved in the hobby it will not succeed, and is known for taking individuals under his wing, introducing them to the hobby, helping them improve their abilities, and then mentoring them to succeed.

Ernie was a key factor in testing and development for Jim Schaefer's ABC Props. He also produced a conversion kit for outboard tunnels which is still in use in the hobby today. Ernie formed a racers group to host the Internats in Jackson, TN, in 2005 and served as the CD. He also served as CD for multiple District 7 races and was always willing to help fill in at other races he attended. He has had much success as a competitor as well.

Ernie has won multiple Nation Champion trophies, and to this day holds the most US-1 titles won at a single event (2004), the most US-1s achieved overall (19 to date), and the only person to date to have been awarded the Excellence of Performance trophy three times in a row. (2005, 2006, and 2007). He was awarded the William LeFeber Sportsmanship Award in 2005, and the President's Cup in 2007. Ernie has also held multiple Time Trial Records throughout his participation in the hobby. He is known for his 7-channel B Tunnel with adjustable pipe length and trim, and for his legendary "John Deere" Twin.

Ernie is an asset to our hobby, not just because of his knowledge of RC racing, but also for his commitment to helping others, from individual racers to clubs.


No new records have been set since the last newsletter report.



We crowned Richard Lind as the very first LSG Super Boat Offshore National Champion. He did this with a single engine in a class that had several twins running in it. For those of you that don't know Richard, he is one of the creators of the Super Boat class in south Florida, and he is also the owner of Rico Boats. He builds several monos, cats, and of course, a super boat. He really showed what his boats could do by winning Super Boat and also LSG 36 Cat. I raced 36 Cat with him and saw first hand what he can do. It was great to see one of the creators of the class win it the first time it was run at a Gas Nationals event in IMPBA. 






































#### Mark Your Calendars for D3 Fall Action

#### **Food for Thought: Common Courtesy in Tent Area**

I have been kicking this around for a few years, and I feel like it is a good time to bring some of this item to light. I have noticed more lately where some racers are walking into other competitors' tents when the owner is—or is not — present and taking a cowling off a boat to look inside, or pulling a measuring tape out to measure after plane, strut depth, ride height, or you see them pickup the boat to look at the bottom without asking. Me personally, I have been taught, if it isn't yours don't touch, but ask if you can touch. 9 out of 10 times if someone asks me if they can look at something on my boat, or needs a baseline on something, I will say, "Go ahead, get what you need." It is nothing more than just the courtesy of asking before taking it upon yourself to measure or touch what is not yours. At an event this year, I put my cowling on my boat and latched it, only to come back and the cowling was sitting next to the boat. Another time, I witnessed an individual measuring someone else's boat while the owner was racing, so it left me to believe this person was trying to hide that there were doing it — only because I asked the owner when they came and they did not know the other racer was doing that. I can imagine if I went into that person's tent, pulled the head off their motor to measure head clearance without asking that they would have a problem? All in all, please have the common courtesy to ask before you touch something in someone else's tent area. When you enter their tent, be aware of the surroundings to where something won't be knocked off a table, or you won't be in the way of the racer working in their area.

# **INSURANCE**

# Summary .....

IMPBA membership dues include commercial general liability and property damage insurance which protects individual members, registered clubs, municipal & state park boards, and private landowners from suits by third parties who may be injured by model power boats that are operated on IMPBA insured bodies of water for which member

clubs have submitted the correct application (on a Club Registration and Insurance Application form), and have been issued an insurance certificate. Since rates or coverages may vary from time to time, up to date insurance information may be obtained from the IMPBA office.

## **Membership Coverage**

All members in good standing will be covered at "sponsored, scheduled, and supervised activities." This means the coverage is good at sanctioned and club races, and open water practice sessions as long as you are following the safety procedures outlined through the IMPBA, and such events take place on an IMPBA insured body of water only. IMPBA's policy is considered a primary policy and would cover the

costs of property damages or injuries to third parties caused by IMPBA event participants that may occur on an IMPBA insured body of water. It would also cover the cost of your legal defense and settlement or award should you be successfully sued - up to the policy limits. A deductible applies per claim. For current coverage and deductible information contact the IMPBA office.

## Non-Member Coverage

The insurance does not cover any person who is not a paid member of IMPBA regardless of what other club or organization he may belong to. Paid members of other boating organizations may pay a single-event fee of \$15 for membership dues **during that event only.** The single-event application and payment must be completed online and can be found at www.IMPBA.net.

Therefore, no person may operate or assist in the operation of a model power boat, or enter the pit area, or operate a retrieve boat at any IMPBA sanctioned event on an IMPBA insured pond, and be covered by this insurance, unless he is a paid member of IMPBA.

#### Insured Sites

- No club may apply for insurance for a body of water presently or previously insured by another IMPBA Registered Club without the permission of that club.
- All Clubs applying for insurance on a body of water should submit a club application and a signed letter from the pond owner, on letterhead, giving their authorization for your particular club to conduct Model R/C Boat activities at that particular site.
- Permanent and temporary structures, such as drivers' stands/scaffolding or bleachers, are not covered by IMPBA insurance.

#### Safety -----

- It is not the intent of IMPBA to issue insurance to any organization that does not comply with and foster IMPBA Safety Rules and Regulations
- Adequate provision shall be made for the safety of the contestants and spectators.
- "NO SWIMMING" signs should be posted in conspicuous places on all sides of the pond.

#### **REMEMBER: SAFE BOATING IS NO ACCIDENT!**

YOU ARE ADVISED that these events may be cancelled due to circumstances beyond the control of this association.

Clubs may not have notified the office of additions or cancellations in time for publication. If you plan to travel a long distance, it is recommended that you contact the race sponsor prior to your departure to ensure this event will take place.

All raffle/drawing prizes are the responsibility of the conducting Club. IMPBA does not guarantee, nor is it responsible for fulfillment of raffle or drawing prizes.

## **REMEMBER: SAFE BOATING IS NO ACCIDENT!**

It's up to all of us to stay safe, so if you see something... say something!

#### **GENERAL**

All IMPBA members and /or contestants are responsible to conduct themselves in a manner consistent with the concept of good sportsmanship: to wit, a person who plays fair and conducts him/herself in an acceptable fashion while participating in IMPBA events.

The use of alcohol or illegal substance and/or abuse of prescription drugs while participating in an IMPBA race or sanctioned event is considered unacceptable conduct and is a Code of Conduct violation.

IMPBA reserves the right to deny membership to any individual who has, at any time, demonstrated unsafe boating practices, been suspended, or banned from another boating organization for any amount of time, or for any reason.

Adequate provisions shall be made for the safety of the contestants and spectators.

Club Safety Officers should inspect the pond area prior to Open Water, or start of events to ensure IMPBA rules are in effect and adequate protections are in place. A first-aid kit should be maintained by the officer.

Boats not considered safe may be denied running privileges. Additionally, boats that show erratic behavior indicating possible control problems may be ordered off the course and given points for "Did Not Finish." The driver must demonstrate the problem has been repaired before he/she may continue in the next heat.

Frequency flags/tags and impound procedures will be used on transmitters. A radio may only be turned on when the correct frequency flag/tag is available.

2.4 Ghz frequency transmitters are exempt from these rules.

#### **SITE SAFETY**

"NO SWIMMING" signs MUST be posted on all sides of pond.

No person shall be permitted in the water without express permission of the Contest Director.

No model boats may run while the retrieve boat is working or any full-size boat is in operation.

Persons under 16 must wear U.S.C.G. approved personal flotation device while operating the retrieve boat. PFD should be available for each person in the boat.

Safety Netting should be placed on all sides of the pond exposed directly to spectators and contestants. Any area not covered by netting MUST be kept free of all people and animals during the event using signs, ropes, or barriers.

Caution tape, signs, barriers, fencing and/or netting shall be used to keep spectators out of the water and a minimum of 25 feet from the shoreline, and signs posted: "No Spectators Beyond This Point"

Race officials, contestants, and assistants (PAID IMPBA only) are the only persons allowed in the restricted pit/engine test area (Neon safety wristbands should be issued to all to easily identify).

An effort should be made to protect boaters in the pit area by using netting, or a raised launch area.

Tent & canopy, or similar, must have in-ground anchor.

Fire extinguishers MUST be in the pit/engine test area.

No smoking in pit/engine test area.

Host club should provide depository for disposal of racers' contaminated fuel

Drivers stands/steps should have reasonably slip-resistant surface and hand-rails on all sides.

#### **SAFE OPERATION**

Whenever running a boat, whether during a race or practicing, there must be a spotter for each driver to watch for unsafe conditions.

When in the pit/engine test/launch areas shoes MUST be worn. Sandals or open-toe shoes are NOT acceptable.

Boaters should test their radio operation before starting an engine.

Always WALK TO THE LAUNCH SITE.

Once a boat passes the entrance buoy, there will be NO RE-LAUNCH.

Never bring a boat to the pit area straight in — ALWAYS RUN PARALLEL TO SHORE while slowing it down.


